Course Description: This course is designed to expose students to healthcare, community

engagement, and professional nursing in countries outside of the United States. Focused study on professional nursing and/or healthcare topics specific to the host country on local, regional and global scales. The

course integrates multiple forms of instruction.

Course Goal: The overall goal of this course is to broaden the students' view of

professional nursing in international settings and gain a better understanding of the four nursing metaparadigm concepts; person, environment, health and nursing within that geographic location.

Course Student Learning Outcomes:

Upon completion of this course, the student will be able to:

- 1. Discuss social norms, customs and healthcare expectations of a geographical region.
- 2. Recognize cultural differences between the United States and the geographical region under study.

- 3. Describe the metaparadigm concepts of person, environment, health, and nursing in the context of the geographical region.
- 4. Examine the similarities and differences of professional nursing in the United States compared to the geographical region under study.
- 5. Assess personal level of cultural awareness and knowledge.
- 6. Apply the knowledge gained from international experience to broaden personal perspectives and improve professional practice when caring for or educating individuals from different cultural backgrounds.

SPECIFIC COURSE DESCRIPTION

The "Medical Spanish and Service Learning in Costa Rica" study abroad program offers undergraduate and graduate Nursing and Clinical Research (CLR) students a unique opportunity to enhance their cultural competence, language proficiency, and global healthcare knowledge. Through immersive Medical Spanish instruction and hands-on service projects, students will engage with local communities to provide care and support, gaining firsthand experience in addressing healthcare challenges in a cross-cultural setting. By integrating language learning with community service, students will broaden their understanding of global health, improve their ability to communicate in clinical environments, and strengthen their ability to think globally while acting locally in their future careers.

SPECIFIC COURSE OBJECTIVES

- 1. Discuss the social norms, customs, and healthcare expectations within Costa Rican communities.
- 2. Recognize cultural and healthcare differences between the United States and Costa Rica.
- 3. Describe the metaparadigm concepts of person, environment, health, and nursing in the context of Costa Rican healthcare.
- 4. Examine the similarities and differences in professional nursing and healthcare research practices between the United States and Costa Rica.
- 5. Assess personal cultural awareness and communication skills in the context of language barriers and global healthcare.
- **6.** Apply the knowledge gained from this international experience to enhance professional practice and research when caring for or working with individuals from diverse cultural backgrounds.
